The Articles of Association (Updated in Academic Year 2016) states that the Governing Body shall consist of 10 Governors as follows:

**2 Parent Governors / 1 Head Teacher / 1 Staff / 1 Local Authority / 5 Co-opted Governors**

\* The Authority Governor is nominated by the Local Authority, Parent Governors are elected by the parent body and Staff Governors are elected by the staff body of the school.

\*\* All Governors' terms of office are 4 years.

The Full Governing Body ratifies decisions following recommendation from the committees/panel above (unless otherwise stated in School Policy/Terms of Reference/Scheme of Delegation), and all minutes are available upon request to the Clerk to Governors, with the exception of confidential minutes.
